If after admission you take your son/daughter out of the school for any reason, then the fee deposited by you will be deducted as per rules. If your son/daughter has been given any kind of scholarship by the government, then you will have to return that too. You are requested to be aware of the facilities available in the school like hostel/food arrangements/sports etc. before getting your son/daughter admitted.

4. छात्रों को विद्यालय में अगली कक्षा में प्रवेश प्रतिवर्ष केन्द्रीय माध्यमिक शिक्षा मण्डल, नई दिल्ली एवं सैनिक स्कूल्स सोसायटी रक्षा मंत्रालय, नई दिल्ली के द्वारा जारी मापदण्डों के आधार पर ही दिया जाएगा। निर्धारित मापदण्डों को पूरा न करने पर सैनिक स्कूल्स सोसायटी, रक्षा मंत्रालय, नई दिल्ली द्वारा समय-समय पर जारी दिशा निर्देशों के अनुसार प्रतिवर्ष छात्र/छात्रा की छात्रवृत्ति की पात्रता का परीक्षण किया जाएगा।

Students will be given admission in the next class of the school on the basis of the criteria issued every year by the Central Board of Secondary Education, New Delhi and Sainik Schools Society, Ministry of Defence, New Delhi. In case of not fulfilling the prescribed criteria, the eligibility of the student for scholarship will be checked every year as per the guidelines issued from time to time by Sainik Schools Society, Ministry of Defence, New Delhi.

5. सभी छात्र/छात्राओं का प्रतिवर्ष स्वास्थ्य परीक्षण किया जाएगा। निर्धारित मापदण्डों के अनुसार अस्वस्थ पाए गए छात्रों को स्कूल से निकाल दिया जाएगा। आपसे अनुरोध है कि आप अपने पुत्र/पुत्री को छात्रावास में उचित व्यवहार व अनुशासन के पालन के लिए प्रेरित करें। यदि आपके पुत्र/पुत्री का चाल-चलन, व्यवहार इस स्कूल के नियमों के विरुद्ध पाई गई तो उसे स्कूल से निकाल दिया जाएगा। इस अवस्था में आप से छात्रवृत्ति की पूरी राशि वापस ली जाएगी।

Health check-up of all students will be done every year. Students found unhealthy as per the prescribed standards will be expelled from the school. You are requested to motivate your son/daughter to follow proper behaviour and discipline in the hostel. If the conduct and behaviour of your son/daughter is found to be against the rules of this school, he/she will be expelled from the school. In this case, the entire amount of scholarship will be taken back from you.

6. प्रवेश के समय आपको निम्नलिखित कार्य करने होंगे:-

At the time of admission, you will have to do the following:-

(क) स्कूल परिसर में स्थित पंजाब नेशनल बैंक की शाखा में अपने पुत्र/पुत्री के नाम एक बचत खाता खोलना होगा, जिसमें कम से कम ₹ 2,000/- जमा करना होगा। इस खाते का संचालन आपके पुत्र/पुत्री द्वारा किया जाएगा तथा इस राशि का प्रयोग वह भविष्य में आवश्यकता अनुसार करेगा। इस हेतु आप अपना व पुत्र/पुत्री का निवास प्रमाण-पत्र, आधार कार्ड एवं पहचान साक्ष्य हेतु आवश्यक दस्तावेज लेकर आएं।

You will have to open a savings account in the name of your son/daughter in the Punjab National Bank branch located in the school premises, in which at least ₹ 2,000/- will have to be deposited. This account will be operated by your son/daughter and he/she will use this amount as per his/her requirement in future. For this, bring your and your son/daughter's residence certificate, Aadhaar card and necessary documents for proof of identity.
